SG acknowledged the pressures that having only one warden places on Margaret and made an appeal for a second church warden/ assistant.

SG expressed heartfelt thanks to Margaret for her support throughout the past year.

4. Minutes of last meeting:

Amendments – change 2222 to 2022, and also amend the incorrect statement that now is the only time we've had one church warden. Otherwise signed as a true record.

5. Reports

SG expressed many thanks to Jean Grierson for her work with the St Margaret's Charities for the Needy and to Dave Scott, our parish giving officer. Many thanks were expressed to all those who are vital to the smooth running of the church, such as the cleaning team, gardening team, the flower committee and also to Shirley Girt who maintains all the church linen. She then introduced and thanked John Grierson, the PCC treasurer, who has worked extremely hard to manage the church finances over the past year.

6. John Grierson, Treasurer, gave a very clear and succinct report of the church accounts.

John then thanked Heather Jasper and Phil Hall for their handover last year and added his personal thanks to John Rendle, the Accounts Examiner. He wanted to assure us all that every penny is signed for twice and always accounted for. Thank you to everyone involved in this process. John also thanked Carol and Mary for all the work they had done in applying for grants for the major projects that the church would be undertaking in 2024.

Questions

Charles Croydon - Are renters required to make payments in advance?

JG - No

Nick Jacob - Re Alpha nurseries - is the school taking over their work?

JG - Some provision by school, Monday to Friday after school with no breakfast club. As such there is limited room usage, so can only raise limited income.

Questions were also asked by Edward Phillips and Ron Llewellyn re church income.

JG - legacies cannot be predicted but are very welcome when they come. We need to build up a fund to continue to cover building costs, but we also would like to spend on non-building projects. JG forecasts that we will still have a reasonable reserve at the end of this year, but that depends on whether there are any unexpected costs on the planned works.

Sarah reiterated her thanks to John for all his hard work on the accounts.

7. Property Sub- committee

8. Church warden report

Margaret thanked George W and Sarah G for all their support.

Vicar Sarah expressed gratitude to Margaret on behalf of the whole church community.

9. Safeguarding: The safeguarding lead role will move to Carol Klug. Deputy lead officer will now be Lucy (Church administrator), with Lucy handling the admin side of the role. If anyone has concerns – tell Carol, Sarah, Lucy – or phone the number on the notice board.

11. Electoral Roll

Treasurer – John Grierson to continue in role.

13. Election of Independent examiner

John Rendle has offered to continue in this role and his offer was gratefully and unanimously accepted.
